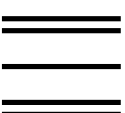

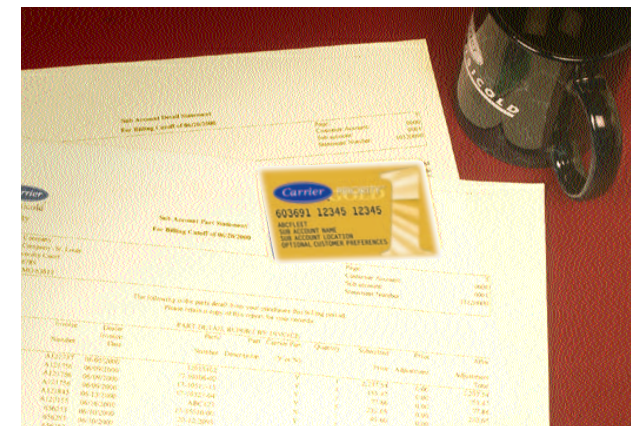

Carrier Transicold Priority Gold Card Canadian Cardholder Agreement

The Carrier Priority Gold Card is issued by and credit is extended by Multi Service Corporation, P.O. Box 10922, Shawnee Mission, KS 66225. Any references in this Agreement to Carrier or Carrier Transicold refer to Multi Service Corporation (MSC). MSC collects and uses personal information ("Information") about a person (a) to consider initiating and to initiate, maintain and develop the relationship with Applicant/Cardholder in connection with offering and servicing of credit, (b) to monitor the Applicant's/Cardholder's purchasing history; (c) to evaluate the Applicant's/Cardholder's credit standing; and (d) as consented to below, to share such information with Carrier Transport Refrigeration & Air Conditioning, Carrier Corporation, so it and its affiliates may identify incidental or related services that may be of interest to the Applicant/Cardholder. Before using the Information for any other purposes, MSC will disclose such purposes to the Applicant/Cardholder and seek the Applicant's/Cardholder's consent. The Applicant/Cardholder may refuse to consent to these other purposes.

An information the containing the information collected ("File") may be opened in Applicant's/Cardholder's name, and that information obtained directly or by means of the authorisation contained in the Credit Application will be kept confidential at the office of MSC whose mailing address is first listed above. Personnel in new accounts, authorisations, collections and customer service departments at MSC and any other employees or agents who require such information in the performance of their duties will have access to the Information in Applicant's/Cardholder's File. Applicant/Cardholder may have access to the information in the File and may rectify such information upon written request to MSC at the address above. Applicant/Cardholder may also have access to any reports and recommendations of any personal information agent and credit agency kept in such File and, where necessary, cause them to be rectified as set out previously.

By Applicant's signature below, Applicant authorises the collection, exchange of, use and communication of information in Applicant's/Cardholder's File by and between MSC and Carrier Transport Refrigeration & Air Conditioning, Carrier Corporation. Applicant understands that this consent will remain valid as long as the Applicant is the holder of a credit card (Cardholder) issued by MSC. Applicant hereby acknowledges that the credit card to be issued hereunder will be used for commercial purposes only in connection with his business enterprise and will not be used for any family, personal or domestic purpose.

Usage of the Carrier Priority Card by the Cardholder named on it constitutes acceptance of the following terms and conditions, as may be amended from time to time. "Usage, by the Cardholder..." includes the retention or use of the card by the Cardholder as named on it or anyone under his/her/s control, including Carrier Priority Gold Cards forwarded to the dealer locations per Cardholder's request. The holder of the charge card is liable for any unauthorised use of the charge card, and the Cardholder agrees to be responsible for any unauthorised use.

A credit line will be assigned to Cardholder's account. This line includes all unpaid purchases, whether billed or unbilled. If, as Cardholder uses the card, the credit line proves to be inadequate, please call 1-866-ROADCARE (1-866-762-3227). Statements will be mailed twice a month and will include a 0.5% service fee on each transaction as determined by Carrier. Cardholder's payment is due within 20 days of the statement date. Statements outstanding more than 20 days will be considered delinquent. Delinquent accounts will be assessed a late charge at a per-billing-period rate of 0.75% (18% per annum) of the amount of the past due invoices, or the maximum amount permitted under the law.

Cardholder may pay the Carrier Priority Gold Card statements by check. If Cardholder's bank should fail to honor payment to MSC or Cardholder's account becomes delinquent, MSC may require immediate and full payment of all outstanding amounts, as well as the return of Cardholder's Carrier Priority Gold Cards. MSC neither sells nor warrants the goods or services obtained from the Carrier Transicold Dealers.

This Agreement will be governed by the laws of the State of Missouri, and it is agreed that jurisdiction of any legal action connected with this Agreement shall lie exclusively in the state or federal courts located in the State of Missouri without regard to the principals of conflict of laws. Notwithstanding the foregoing, MSC may, at its option, choose to pursue legal action against the Cardholder in any province in which the Cardholder does business or where jurisdiction may otherwise be proper.

In the event of the Cardholder's breach or default under the terms of this Agreement, the Cardholder will be liable to MSC for all costs and expenses, including late charges and reasonable attorney's fees or other costs of collection, incurred by MSC in enforcing its rights hereunder. The Cardholder agrees that in the event of default in payment, MSC may institute suit against the Cardholder in the aforesaid courts, regardless of where the Cardholder is geographically located or does business.

Either you or MSC may terminate this Agreement at any time. Once the Agreement is terminated, you must return to MSC all cards in your possession or control. Payment of all outstanding amounts must be made upon termination. If cards are lost or stolen, it is the Cardholder's responsibility to call MSC immediately to prevent unauthorised usage. Call 1-866-ROADCARE (1-866-762-3227) to report lost or stolen cards. Please follow up with written notification sent directly to Multi Service Corporation, P.O. Box 10922, Shawnee Mission, KS 66225-9022.

The parties confirm their express wish that this Agreement and all documents related thereto be drawn up in English. *Les parties confirment leur volonté expresse de voir le présent contrat et tous les documents s'y rattachant être rédigés en anglais.*
